THE PROBLEM

Decisions and delivery live in different systems

Minutes sit in one folder, progress photographs in another, and the executive report is assembled by hand the week before the review. By the time an issue reaches management, the trail back to the decision that caused it has gone cold.

Fragmented record

Attendance, minutes and actions are captured in tools that do not talk to each other.

Unverifiable progress

Field updates arrive as prose and photographs with no fixed location, time or reviewer.

Manual reporting

Executive visibility depends on someone re-keying the same facts every cycle.

Every one of these is a symptom of the same gap: the decision and the delivery are not held in the same record.

Two applications on one governed platform



Naya

Meetings, attendance, minutes, decisions, actions, site visits and organisational time.



Sky Hawk

Projects, structured field reports, progress, geotagged evidence, approvals and GIS.

Shared platform services

- Identity and single sign-on
- Workflow and notifications
- Search and audit
- Organisation directory and RBAC
- Documents, media and GIS
- Analytics and API gateway

The loop closes when the evidence returns to the next agenda – which is why the same project identifier runs through both applications.

WHAT CUSTOMERS GAIN

One institutional record, four practical gains

Accountability

Named owners and deadlines against every approved decision.

Time visibility

Officer-hours, meeting load and field time measured, not estimated.

Institutional memory

Searchable minutes, decisions, actions and evidence.

Executive clarity

One roll-up across units, projects, decisions and delivery.

TRUST AND GOVERNANCE

- Human-approved official records — no AI draft becomes a minute on its own.
- Privacy-by-design boundary: official activity, not continuous personal tracking.
- Role-scoped access, audit logging and configurable retention.
- Deploy to approved cloud, government data centre or hybrid.

Best fit

Organisations running capital or field-delivered programmes where formal meetings set direction, and management is accountable for proving that the direction was carried out.

Start with one project

Take a single high-value project or organisational unit through a governed pilot, and prove the management value before scaling.
